#### WHO SHOULD INVEST



#### **RISK INDICATOR**









#### **FUND COMMENTARY**

In April, U.S. President Donald Trump announced reciprocal tariffs, triggering heightened volatility across global markets. Since the announcement, U.S. assets have underperformed, as concerns grow over the continued legitimacy of the U.S. dollar's safe-haven status.

Domestically, disagreements over the national budget have sparked concerns about a possible collapse of the Government of National Unity (GNU). However, these fears have been allayed, with the proposed VAT increase being scrapped and dialogue resuming between the ANC and DA. The Minister of Finance will now be hoping that the third attempt proves successful, with the revised budget scheduled to be tabled on 21 May.

The 12-month NCD rate rallied 28 basis points and 3-month JIBAR by 2basis points over the month. The market is currently pricing in close to two interest rate cuts over the next 12 months as shown in the FRA curve.

The Fund remains well-positioned to fully capitalize on the current cycle, with our step rate note resetting at levels significantly above bank FRN spreads. Coupled with high-quality credit, this continues to enable the Fund to outperform its benchmark.

The Fund delivered strong performance over the month, bolstered by positively yielding assets, which contributed to the month's return.

#### **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.
