MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

WHO SHOULD INVEST

Investors seeking significant real returns over the long term but who are cost conscious. The Fund is suitable for investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically exhibit more volatility and potential for capital losses due to higher exposure to equities and exposure to offshore markets where currency fluctuations may result in capital losses. These portfolios typically target returns in the region of 5% - 6% above inflation over the long term.

FUND COMMENTARY

Recent developments in global economic policy highlight a complex and evolving landscape, shaped by ongoing debates around inflation targets, shifts in monetary policy, and changing trade dynamics. Major economies continue to face the challenge of balancing inflation control, economic growth, and geopolitical uncertainty - all under the weight of both domestic and international pressures.

Global economic conditions remain fraught with uncertainty as countries wrestle with inflation control, trade tensions, and geopolitical conflicts. Central banks are navigating a delicate path, balancing the need for monetary easing with the risks of inflation, while governments face pressure to align fiscal policies accordingly. The evolving trade landscape, particularly between major economies such as the US, Canada, China, and the EU, will continue to shape economic outcomes in the near term. Against this backdrop, ongoing data releases and policy decisions will be critical to understanding whether economies can maintain growth without succumbing to recessionary pressures or escalating trade disputes.

At the recent Economic Policy Symposium hosted by the federal reserve at Jackson Hole, Federal Reserve Chair Jerome Powell hinted at the possibility of a rate cut next month, contingent on key economic indicators, particularly the unemployment rate. Powell's remarks underscored a cautious, data-driven approach to monetary policy, focusing on the long term despite political pressures. However, President Donald Trump's ongoing criticism of the Fed - highlighted by calls for the resignation of Fed Governor Lisa Cook - raises concerns over central bank independence. Powell's speech triggered a market reaction with declines in Treasury yields and the US dollar, with the US Dollar Index Spot losing -2.20% by the end of August. This affected gold prices and fuelled speculation about a September rate cut. Meanwhile, tariff-driven cost pressures persist, though Powell expressed cautious optimism that these may be temporary.

The decision to lower South Africa's official inflation target to 3% remains uncertain. Finance Minister Enoch Godongwana, responsible for setting the target, has clearly stated that no announcement will be made on reducing the inflation target in the upcoming Medium-Term Budget Policy Statement (MTBPS). He emphasised that any changes would require formal consultation involving the National Treasury, the South African Reserve Bank (SARB), Cabinet, and other key stakeholders. This stance contrasts with the SARB's advocacy for a 3% inflation target, which they believe would enable repo rates to stabilise slightly below 6%, down from the current 7%. Without government support and aligned fiscal spending, the SARB might be forced to raise interest rates further to combat inflation, complicating efforts to achieve the lower target.

In August, equity markets responded positively to these developments. Globally, equity markets posted gains, with the MSCI World Index up 2.49% and the MSCI Emerging Markets Index rising 1.22%. Locally, the FTSE/JSE All Share Index rose by 3.37%, driven largely by strong performance in the mining sector.

The Fund currently holds a moderately negative view towards South African equity, developed and emerging market equity and local bonds. Our view on the rand remains moderately negative.

Fund performance was positive for the month due to continued good performance in local equities.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

This yield is subject to change as market rates and underlying investments change.
