FUND DESCRIPTION

The Fund aims to achieve real growth in capital over time. The Fund invests in a combination of collective investment schemes portfolios, providing exposure to equities, bonds, preference shares, listed property stocks, and cash. The Fund may invest 45% of the portfolio offshore and will always comply with the Prudential Investment Guidelines, which makes the Fund ideal for use in medium and long term savings policies. The Fund employs a best-of-breed investment philosophy, thus allowing the inclusion of both passive and active strategies with demonstrated superior ability in various asset classes.

FUND OBJECTIVES AND POLICY

The Fund is suitable for investors with a moderate risk profile, seeking stable capital growth and moderate levels of interest income. The Fund is further suited to investors with a longer investment horizon and is ideally suited to those investors who prefer a combination of different, yet complementary, investment managers in one Fund. The Fund is suited to investors who require that the asset allocation decision is made on their behalf within prudential guidelines. The Fund shall comply with the relevant provisions of the Pension Fund Act of 1956 and specifically as set out in Regulation 28.


