

### **Fund Commentary**


Financial markets delivered mixed performances in the first quarter, mirroring a fragmented macroeconomic environment. In South Africa, the All-Share Index rose 5.94%, buoyed primarily by a 33.74% surge in resources. Financials and Industrials were largely flat. The All-Property Index fell 4.25%, whereas the All-Bond Index and Inflation-Linked Bonds each rose 0.70% and the SteFI Index gained 1.89%. Domestic fixed income indices benefited from yield compression at the short end of the curve, which helped offset losses at the longer end — the latter seemingly reflecting the deteriorating fiscal outlook, potential US funding cuts, uncertainty around the Government of National Unity, and concerns over South Africa"s AGOA membership. Globally, U.S. markets underperformed, with the S&P 500 falling 4.59% and the Nasdaq dropping 8.25%, weighed down by losses in major tech stocks. US assets were weighed by heightened uncertainty stemming from the Trump administration's aggressive tariff rollout, which raised stagflation concerns and led to downward revisions in global growth forecasts and U.S. equity targets. In contrast, the MSCI World ex-USA gained 5.50%, led by strong performances in Germany and Spain, driven by a €1 trillion German stimulus package. Global Bonds provided the much-needed ballast the Bloomberg Global Aggregate Bond Index rising 2.64%, reversing the previous quarter"s losses.

The 27four Balanced Fund delivered a resilient performance in the first quarter, declining by just 0.23%, supported by its diversification across major asset classes. However, it lagged the medium-equity portfolio category average primarily because of the underperformance of the domestic equity building block, where underlying managers lacked sufficient exposure to the high-performing resources sector. Additionally, the reduction in offshore assets early in the quarter, combined with manager outperformance elsewhere, was not enough to offset the drag from domestic allocations, leading to the fund's overall lag in performance. Looking ahead, we expect the Trump presidency to remain a key source of uncertainty. Beyond tariffs, we are anticipating further controversial policy rollouts from Trump. These may include intensified immigration enforcement, deregulatory pushes in energy and finance, and the potential establishment of new federal agencies like the proposed "External Revenue Service." Each of these could carry significant implications for global markets and geopolitical relations – further reinforcing the need for a diversified, flexible, and risk-aware portfolio approach. On tariffs, the April 2 "Liberation Day" measures marked a major escalation, triggering retaliation from China, the EU, and Canada. We believe tariffs are not merely tactical for Trump—they are central to his broader agenda of reshoring manufacturing and funding extended tax cuts. As a result, the global trade landscape is likely to undergo lasting structural change. While we do not expect the full suite of proposed tariffs to be implemented—given likely pushback from trading partners and the economic impact on U.S. consumers and businesses—we believe a more protectionist baseline is now firmly in place. Against this backdrop, our base case has shifted to one of sub-trend growth and elevated inflation. In response, we are maintaining our bias toward domestic assets, Europe, and China, while reducing exposure to expensive U.S. equities. O

# Glossary

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Best month: Largest increase in any single month.

Highest & lowest return: The highest and lowest returns over any 1 year period since the inception date

Max drawdown: The maximum peak to trough loss suffered by the Fund since inception.

NAV: The net asset value represents the assets of a Fund less its liabilities.

**Sharpe ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard deviation: The deviation of the return stream relative to its own average.

**Tracking error:** The volatility of the difference in returns between a Fund and its Benchmark. Also known as active risk

% positive months: The percentage of months since inception where the Fund has delivered positive return

### **Fund Specific Risks**

**Currency exchange risk:** Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.

**Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
