Fund Description

The 27four Diversified Income Fund is a low risk multi-managed portfolio focusing on income generating assets. It aims to provide relative capital stability and optimal income returns. In order to achieve its investment objectives, the fund will utilise a combination of underlying funds investing directly in fixed income securities, listed property and other income generating securities in both South Africa and internationally.

Risk Profile




Generally low risk portfolios have minimal equity exposure or no equity exposure, resulting in far less volatility than more aggressively mandated portfolios and in turn the probability of capital loss (permanent/temporary) is less likely. However, expected potential long-term investment returns could be lower over the medium to long-term.

Fund Commentary


The first quarter of 2025 was marked by heightened global uncertainty, driven primarily by the Trump administration"s chaotic rollout of tariffs against US major trading partners. This protectionist stance raised stagflation concerns, prompting investment banks to cut global growth forecasts and revise S&P 500 targets downward. This, coupled with rising geopolitical tensions in the Middle East and strained U.S.—South Africa relations—culminating in the suspension of aid and threats to AGOA benefits—further weighed on markets. Locally, South Africa's government of national unity faltered over fiscal disagreements, adding to domestic instability and investor caution.

In debt markets, global bonds rebounded strongly in the first quarter, supported by a decline in U.S. Treasury yields reflecting a shift toward high-quality fixed income amid ongoing market volatility. The Bloomberg Global Aggregate Bond Index (+2.64%) ended the quarter positively, rebounding from previous quarter loses. In the South African bond market, both the JSE-All-Bond Index and CILI returned 0.70%, reflecting stability despite fiscal uncertainty, with investors showing caution but not abandoning domestic debt—signalling improving market depth and resilience. The Diversified Income Fund returned 2.14% for the quarter against its benchmark's 2.09%. The macro-outlook has become more fragile following the escalation in U.S. trade tensions, with President Trump's broad tariffs reviving global recession fears and amplifying policy uncertainty. Central banks now face a delicate balancing act between containing inflation and supporting growth, while markets remain focused on earnings resilience and geopolitical risks. We are a bit cautious on SA bonds due to headwinds facing the domestic market. Momentum has also been increasing towards developed market bonds as they have emerged as a safe haven amid trade war concerns. The fund continues to adhere to its policy objective.

Glossary

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Best month: Largest increase in any single month.

Highest & lowest return: The highest and lowest returns over any 1 year period since the inception date.

Max drawdown: The maximum peak to trough loss suffered by the Fund since inception.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Sharpe ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard deviation: The deviation of the return stream relative to its own average.

Tracking error: The volatility of the difference in returns between a Fund and its Benchmark. Also known as active risk

% positive months: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Currency exchange risk: Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.

Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
