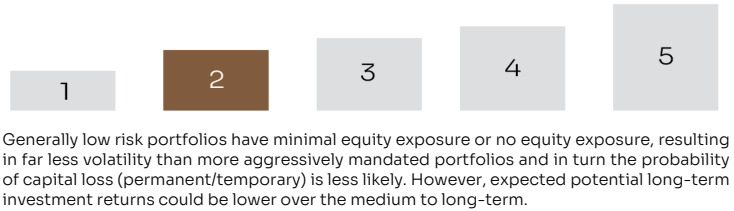

In order to achieve its investment objectives, the fund will utilise a combination of underlying funds investing directly in fixed income securities, listed property and other income generating securities in both South Africa and internationally.

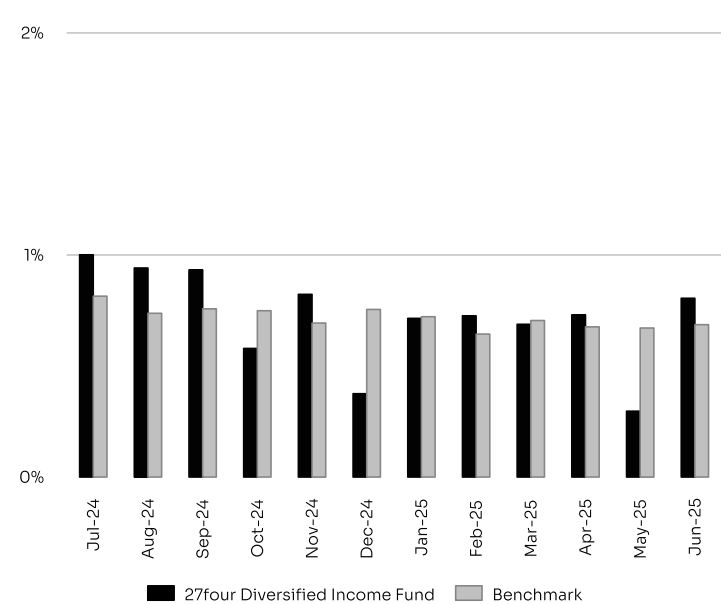


## Fund Commentary

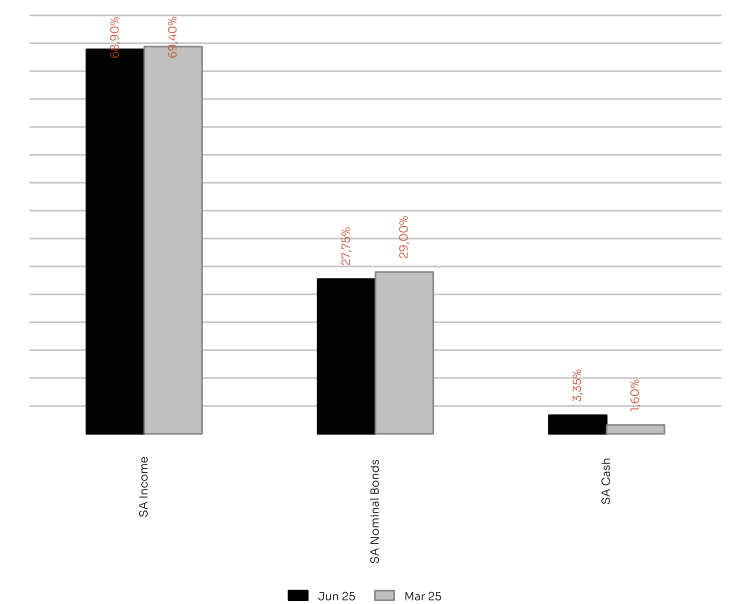
Inflation risks moderated across major developed economies, shifting expectations for future interest rate cuts. In the U.S., both headline and core inflation were softer than expected, reaching their lowest levels since 2021. Headline CPI fell to 2.4% in May, down from 2.8% in Q1 2025, while core inflation held steady at 2.8%. This was due to falling energy and food prices. The data lifted investor hopes for Fed rate cuts in the second half of the year. The Federal Reserve held rates at 4.25%–4.5% in June, with Chair Powell emphasising caution due to tariff uncertainty. Still, the Fed's projections included two cuts in 2025, and one 25 bps cut in both 2026 and 2027. Locally, inflation remained below the South African Reserve Bank's target of 3% to 6% as headline inflation rose slightly to 2.8% in May, up from 2.7% in March. The South African Reserve Bank (SARB) is currently reviewing its inflation-targeting framework, with consideration being given to adopting a point target of 3.0%, replacing the existing 3%–6% target range with a midpoint of 4.5%. This potential shift signals a move towards greater monetary policy precision and aligns with global best practices, where many central banks operate with a clear point target to better anchor inflation expectations. SARB Governor Lesetja Kganyago has argued that although the current framework has served South Africa reasonably well, a 3.0%-point target would help entrench lower inflation expectations and support a more stable macroeconomic environment in the long term. Should this change be implemented, it may prompt a more conservative approach to interest rate cuts, as SARB would need greater confidence that inflation is on a sustainable path to 3.0% before easing policy. Meanwhile, core inflation which excludes volatile food and energy prices, declined to 3.0% in May 2025, down from 3.1% in March, reflecting contained underlying price pressures in the economy. The SARB cut interest rates by 25 basis points in May 2025 on the back of stable inflation and strong rand.

South Africa economic activity remains sluggish, despite growing optimism surrounding the Government of National Unity (GNU) and a more stable energy supply since the third quarter of 2024. The GDP rose by 0.1% in Q1 2025, following a 0.4% increase in Q4 2024. The major contributor to GDP was agriculture, transport, trade, and finance, which rose by 15.2%, 2.4%, 0.5% and 0.2% respectively. Manufacturing and mining were the major detractors from overall growth, contracting by 2.0% and 4.1%, respectively. Against this backdrop, the Diversified Income Fund returned 1.84% for the quarter against its benchmark's 2.05%. The impairment of the Bridge Taxi Finance subordinated debt dragged on performance (0.46%). The fund continues to adhere to its policy objective.

Glossary

**Annualised performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Best month:** Largest increase in any single month.

**Highest & lowest return:** The highest and lowest returns over any 1 year period since the inception date.

**Max drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Sharpe ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard deviation:** The deviation of the return stream relative to its own average.

**Tracking error:** The volatility of the difference in returns between a Fund and its Benchmark.Also known as active risk.

**% positive months:** The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

**Currency exchange risk:** Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.

**Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed.The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
