

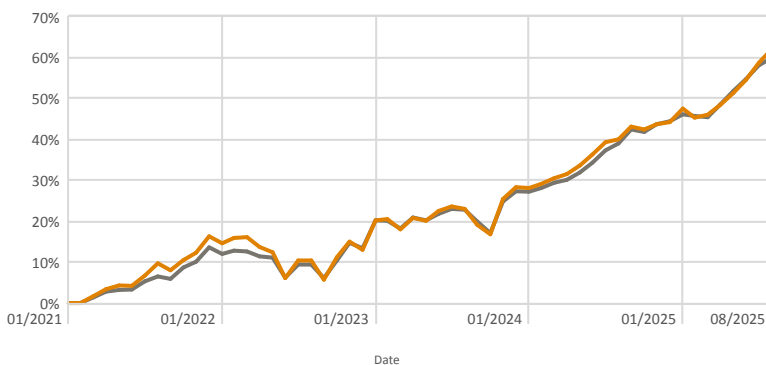
INVESTMENT OBJECTIVE

The Aluwani BCI Balanced Fund aims to generate a moderate to high long-term total return by investing a diversified spread of investable asset classes.

INVESTMENT POLICY

The portfolio's net equity exposure ranges between 0% and 75% of the portfolio's net asset value. The portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

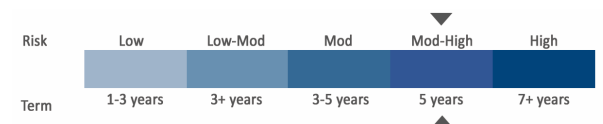

RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
