INVESTMENT PHILOSOPHY

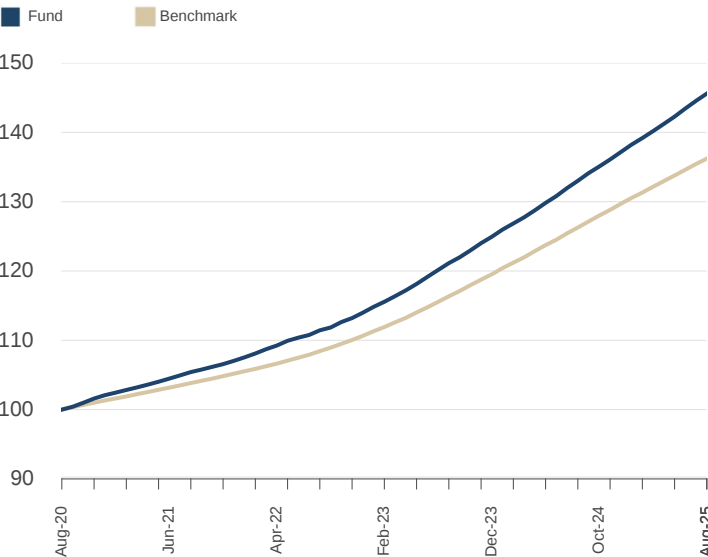
The Anchor BCI Core Income Fund aims to preserve capital, whilst providing income returns higher than those offered by traditional money market portfolios. Investments to be acquired for the portfolio may include assets in liquid form, money market instruments, bonds, fixed deposits, floating-rate instruments, and other interest-earning instruments. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in South Africa as well as other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee, and of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective. The portfolio may from time to time invest in listed and unlisted financial instruments, in order to achieve the portfolio's investment objective.

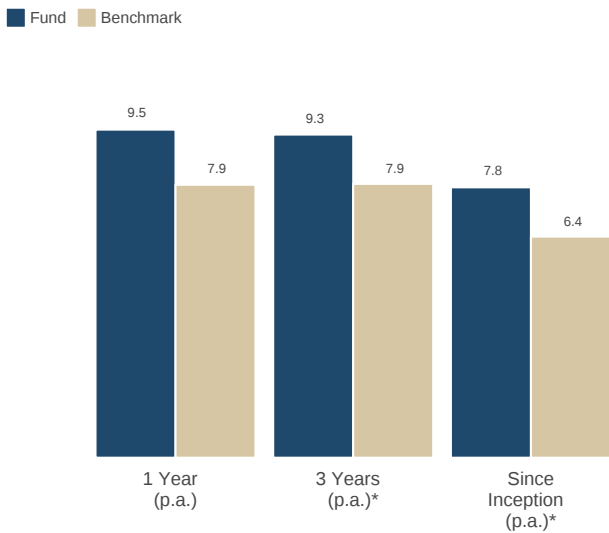

FUND MANAGER COMMENTARY AT 31 AUG 2025

Cyclical and political forces are conspiring to push the US Federal Reserve (Fed) in a dovish direction. The former is driven by a softening labour market, which Fed Chair Jerome Powell flagged at Jackson Hole. The latter is spearheaded by US President Donald Trump’s efforts to pack the Federal Open Market Committee (FOMC) with dovish members. Ultimately, US treasury yields are caught between a softening labour market and the assault on the Fed’s independence. The US Treasury curve is likely to continue steepening, with the 2s30s spread hovering around 130 bpts. Domestically, market participants are recalibrating inflation expectations lower, following recent commentary from the National Treasury and the South African Reserve Bank (SARB) reaffirming their commitment to a lower inflation target. This has driven a notable downward shift in the breakeven curve this year. In the derivatives market, current pricing implies that the local policy rate may bottom out at around 6.5%. To continue taking advantage of the high policy rate environment, over 90% of the portfolio is allocated to floating-rate notes. To partially mitigate the decline in income as the policy rate falls, the portfolio includes inverse floaters, managed within strict duration parameters. The portfolio’s average life is 3.5 years, with a weighted average credit spread of 1.63%. In an environment where credit spreads continue to tighten, the fund has been able to maintain its credit spread. Approximately 85% of holdings are AAA and AA-rated instruments, ensuring low credit risk. The fund continues to harvest low-risk credit premiums. Its primary objective remains capital preservation while delivering income returns that exceed those of traditional money market portfolios.
