INVESTMENT OBJECTIVE

The **Anchor BCI Diversified Stable Fund** is a multi-managed cautious risk profile portfolio with the objective being to provide investors with a high level of income and capital stability. This Fund is appropriate for clients who want exposure to Anchor's capabilities in a solution that is appropriately blended and diversified with other offerings to ensure a more consistent return profile.

INVESTMENT PHILOSOPHY

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. To provide a limited level of capital protection, the portfolio's equity may be as high as 40% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money-market instruments, interest-bearing securities, bonds, debentures, corporate debt, equity securities, other interest-bearing securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.




RISK PROFILE: LOW-MODERATE

- The expected potential long term investment returns are lower over the medium to long term than higher risk portfolios.


FUND PERFORMANCE SINCE INCEPTION

Global markets delivered positive returns in July, buoyed by improving trade dynamics, steady monetary policy, and strong corporate earnings. Equities outperformed across most regions as investor sentiment improved and macro uncertainty eased. In the US, equity indices reached record highs, supported by robust 2Q25 earnings and trade progress with both Europe and Japan. The US Federal Reserve (Fed) kept rates unchanged amid moderating inflation, while bond yields remained range-bound, anchoring risk appetite. European markets were stable following a revised trade deal with the US, which helped reduce tariff concerns. The euro weakened, boosting export prospects, while inflation moved closer to the European Central Bank's (ECB) 2% target. With policy rates on hold, bond markets and equities saw modest gains. Japan recorded a sharp equity rally after striking a favourable trade agreement with the US. Exporters benefitted from yen weakness, while bond yields rose on speculation of a shift in the Bank of Japan's policy stance. Locally, South Africa (SA) saw gains in bonds and equities as inflation remained at the lower end of the target range. The SA Reserve Bank (SARB) cut rates by 25 bpts to 7.00% and signalled a shift to a more accommodative stance, supporting local markets despite global trade headwinds. The portfolio outperformed its benchmark and peers during the month, driven by our continued overweight to local South African assets, which continued to deliver pleasing relative
