INVESTMENT OBJECTIVE

The **Anchor BCI Equity Fund** is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT PHILOSOPHY

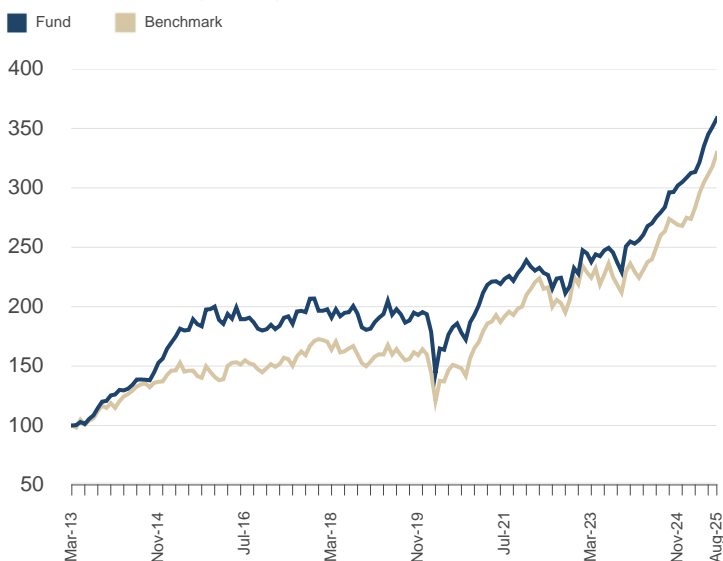
The portfolio is constructed from bottom-up, fundamental research with an investment philosophy that favours quality stocks with superior returns on capital, cash flows and pricing power. While acceptable valuation is an important component of the stock-selection process, the fund's style is not "value" – investments will be made in premium-rated stocks where the growth outlook and quality profile warrants it. The fund will also own shares that are often not well researched, yet offer exceptional valuation-driven opportunities. The quality of companies included is judged by rates of earnings growth, return on capital employed, cash conversion and stability of margins. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency, interest rate and exchange-rate swap transactions for efficient portfolio management purposes. The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value.

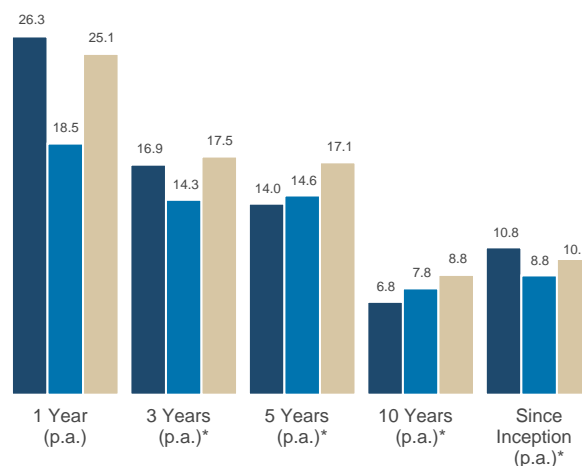

- Therefore, it is suitable for long term investment horizons.

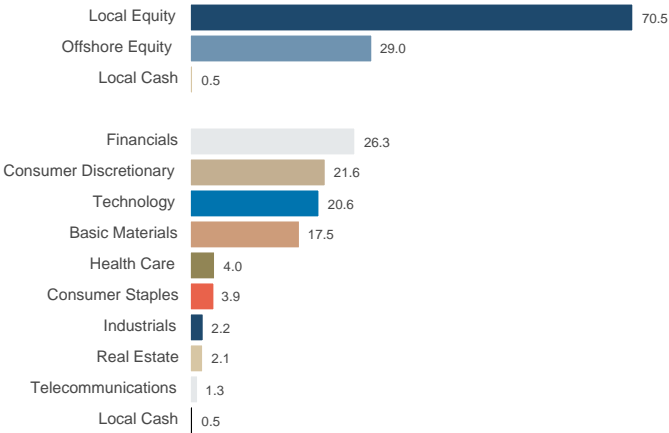
FUND PERFORMANCE AT 31 AUG 2025 (%)

FUND MANAGER COMMENTARY AT 31 AUG 2025

The Anchor BCI Equity Fund returned 2.0% for August, underperforming its benchmark, the FTSE/JSE Capped SWIX Index, which gained 3.5%. However, it is important to note that a significant rally in gold miners, tracking the gold price higher (+4.8% MoM), was the primary driver of the index’s performance. Gold producers generated three-quarters of the JSE’s return in August, and when combined with the platinum group metal (PGM) counters, contributed over half of the JSE’s YTD performance. Consequently, the fund’s structural underweight to these sectors was the primary detractor from relative performance. At a stock level, the positive contributors included Naspers (+3% MoM) and Prosus (+5% MoM), which continued their positive momentum. The fund also benefitted from its banking exposure, with solid performances from Standard Bank (+6% MoM) and Absa (+5% MoM). In contrast, consumer-facing stocks lagged amid ongoing pressure on household finances, with Lewis (-7% MoM), Pepkor (-7% MoM), and Southern Sun (-8% MoM) all declining. During the month, the Fund began pairing underweights in the telco sector, positioning that has hurt so far in 2025. The pullback, specifically in MTN, has piqued our interest, with earnings momentum still moving firmly in the right direction.
