INVESTMENT OBJECTIVE

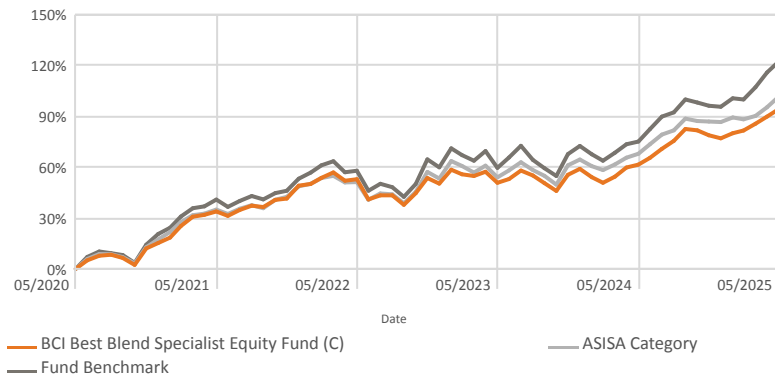
The BCI Best Blend Specialist Equity Fund is a specialist multi managed equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT POLICY

The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include forward currency, interest rate and exchange rate swap transactions.

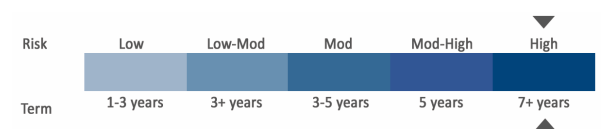
