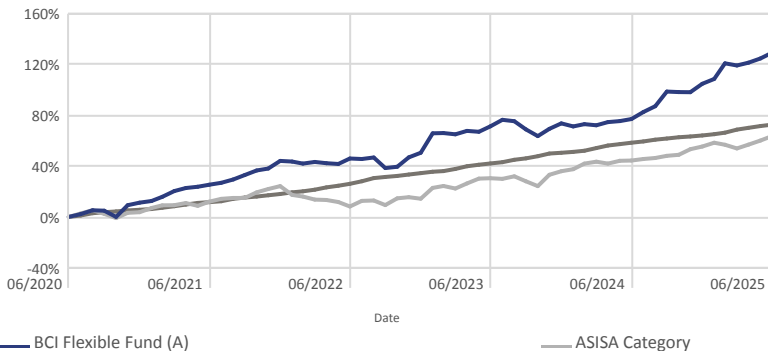
The BCI Flexible Fund is a specialist portfolio, having the primary objective of high capital growth and a reasonable level of income for investors.

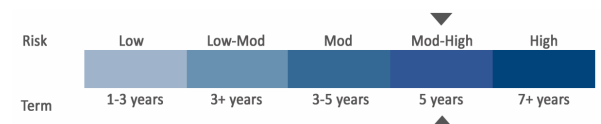

Moderate - High Risk
