

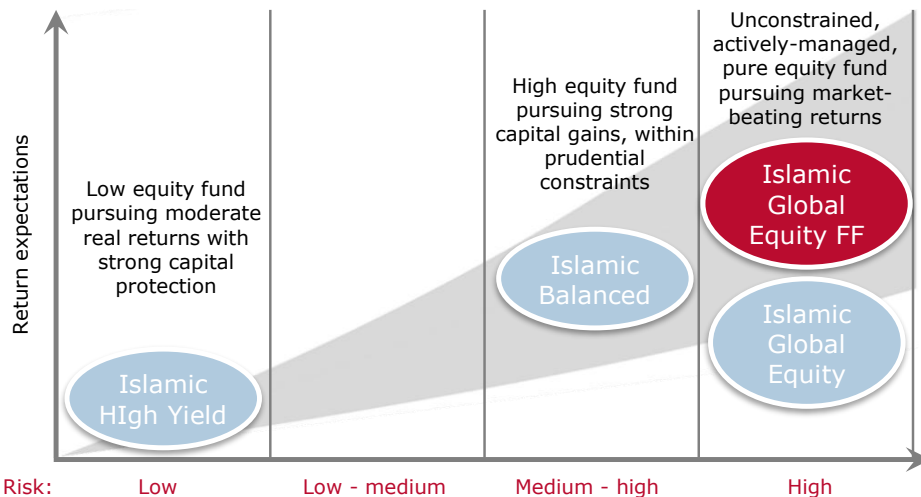

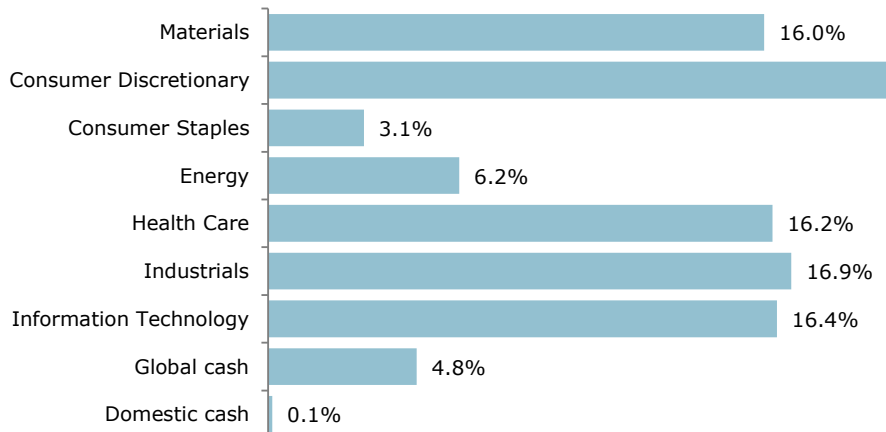

Asset and sector allocation

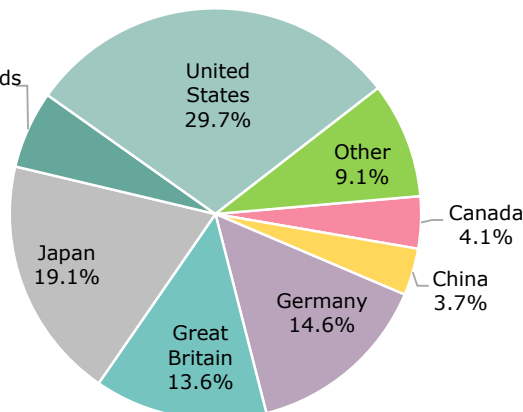

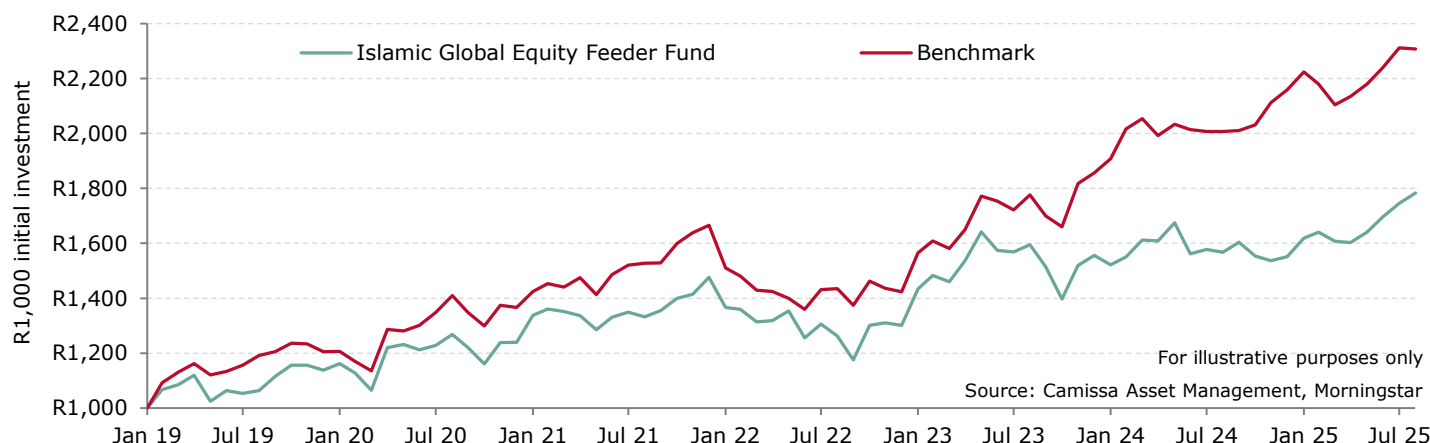
