INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

It's almost hard to believe that equity markets held up reasonably well in April, given the chaos unleashed by Trump's "Liberation Day" tariff announcements at the beginning of the month. The U.S. president announced tariffs that were far broader and steeper than expected, sending markets into a tail spin. Most asset classes were taken on a rollercoaster ride, with equities swinging back and forth like a pendulum between deep red and strong green days. Despite the drama, the MSCI World Index pulled off a surprising monthly gain of 0.89% — not bad, considering it suffered back-to-back daily losses of 4.22% and 3.75% in the first week.

With a third of 2025 already ticked off the calendar, developed markets are trailing. The MSCI World Index is down 0.92% year-to-date, thanks in large part to U.S. equities losing steam. The S&P 500 dropped 0.68% in April, bringing its year-to-date performance to -4.92%. It could have been worse - but the 90-day pause on 'reciprocal' tariffs (excluding China) helped calm nerves and likely prevented a full-blown capitulation.

Not all developed markets were caught in the storm. Europe and Japan danced to a different tune, with the EuroStoxx 600 and Nikkei 225 jumping 5.36% and 6.32% respectively. Much of the buoyancy came from a weaker U.S. dollar, which gave a leg up to the euro and yen. Emerging markets were anything but calm, with China firmly in the spotlight - and in the crosshairs of the latest tariffs. Despite the noise and rising fears of a trade war, emerging markets outshone their developed peers. The MSCI Emerging Markets Index rose 1.31% in April and is up a healthy 4.28% year-to-date. That's all the more impressive considering China's CSI 300 Index fell 4.23% in April and is down 3.81% for the year, weighed down by its own retaliatory moves.

The top contributors to the Fund's performance were Microsoft (5.3%), Broadcom (15.0%) and Netflix (21.4%). Detractors included Apple (-4.3%), United Health (-21.4%), and Meta (-4.7%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
