# HOLLARD BCI CONSERVATIVE GROWTH FUND OF FUNDS (B)

## **INVESTMENT OBJECTIVE**

The Hollard BCI Conservative Growth Fund of Funds aims to deliver a stable level of income combined with long term capital stability by actively managing the portfolio's asset allocation at a strategic level.

### **INVESTMENT POLICY**

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act, subject to a maximum net equity exposure of 40% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in, amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities.


