Fund objective

The goal of the Pure Hedge Fund is to offer investment stability and downside protection while growing investors' purchasing power. We aim to deliver returns above inflation over the medium term.

What does the fund invest in?

The fund can invest in a wide range of assets, such as listed shares, bonds and property, as well as cash and cash equivalents, both in South Africa and internationally.

Important fund characteristics and risks

The fund managers seek to identify undervalued securities that offer strong upside potential over the medium to longer term. We conduct rigorous research to understand the companies and securities that we invest in to determine their intrinsic value, which allows us to identify opportunities with the best expected returns. The fund typically invests in a wide range of assets, with a preference for shares and fixed income instruments. The fund managers strive to reduce risk through disciplined hedging practices and by maintaining high levels of liquidity to minimise correlation to the equity market.



FUND COMMENTARY

Quarterly Performance

The Peregrine Capital Pure Hedge Fund delivered a net return of +1.78% for the first quarter of 2025. This compares with the SA Multi Asset- Low Equity Index, which gained 1.01%% in the quarter.

Attribution

Exposure to the mining, payments and ecommerce sectors generated positive performance, while exposure to index futures industrial and technology sectors detracted from fund performance in the quarter.

Macro

The local equity market performed strongly during the quarter, mainly driven by a significant rally of 35% in the resource sector, a significant underperformer in the final quarter of 2024. The likes of Prosus and Richemont, significant components of the index, also contributed strongly to index returns, while the performance of the banking, industrial and retail sectors was more muted. Investors continue to prophesise about the longevity of the GNU given a seemingly intractable impasse on the budget, which may prove to be a deal breaker in the fullness of time. But despite these meaningful risks, local bonds and the Rand have been remarkably stable throughout the period.

Internationally, unloved equity markets in Europe and China performed extremely well in the quarter, while much of the previous optimism about the USA waned rapidly on the back of government spending cuts and the prospect of US tariffs. The European rally appears to have been mainly valuation driven, while the Chinese government continues to stimulate that market with a host of fiscal and monetary tools that are designed to kick start an otherwise lacklustre economy. In the USA, the Trump administration appears hellbent on restructuring the US economy by balancing the budget, reducing the long-term cost of borrowing and resetting the rules of global trade so as to drive sustainable and higher economic growth. While it is difficult to forecast how this grand experiment will play out, we are hopeful that the administration will remain pragmatic in their approach toward management of the world's largest and most important economy.

Portfolio Construction

At quarter end, gross exposure reduced from 134% to 132%, while net exposure to equities and real estate increased from 18% to 21%. Exposure to bonds fell from 12% to 10% while net cash and money market positions were fairly stable at 69%. While portfolio net exposure has remained fairly similar to last quarter, the composition of the underlying investments has changed quite meaningfully. At the outset of the decline in the US market, we purchased portfolio insurance in the form of index put options that provide downside protection in the event of a protracted bear market. While limiting downside risks associated with existing US exposure, the option insurance also provides the confidence to engage selective US opportunities with more conviction as the risk reward equation becomes more favourable. We purchased select US technology names where valuations are now far more compelling, but meaningfully reduced exposure to companies in the Chinese technology space as prospective returns reduced. We increased exposure to South African retailers, banks and insurers in light of more constructive outlooks and attractive valuations.

Outlook

The volatility that we anticipated at the end of last year arrived with a bang in the first quarter of 2025. Geopolitical uncertainties around US tariffs, chip restrictions, and ongoing wars in the Middle East and Ukraine continue to stoke inflation fears. Advancements in AI continue to exceed our expectations and are likely to have a profound impact on the manner in which companies operate going forward. We remain focused on identifying stock specific opportunities that offer attractive risk reward prospects, while concurrently prioritising downside protection. Our exposure is now more biased to opportunities in the US and South Africa, rather than Europe and China. Our team remains excited about the opportunities and challenges ahead, and endeavour to continue compounding investor capital at the best possible rate, employing the same tried and tested methods we have used for 26 years.

GLOSSARY

Annualised performance: reflects longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period.

High Water Mark (HWM): The highest point in value that the investor's unit has reached. The HWM mark ensures that Peregrine Capital does not get paid a Performance Fee for the same performance twice. The HWM is updated at each Crystallisation Point.

Maximum drawdown: the largest peak to trough decline during a specific period of investment.

Total Expense Ratio: includes the annual service charge, performance fee and administrative costs, but excludes VAT and fund transaction costs, expressed as a percentage of the average monthly value of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return.

Transaction Costs: are the costs relating to the buying and selling of the fund's underlying assets, expressed as a percentage of the NAV. Transaction costs are a necessary cost in managing the fund and may impact the returns.

Total Investment Charge is the sum of the TER and TC. These should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund and the investment decisions of the fund manager. Since the fund returns are quoted after the deduction of these expenses, the TER and TC should not be deducted again from published returns.

The prime broker appointed for the fund is Peresec (Pty) Ltd ("Peresec"). The fund achieves its leveraged positions through the utilisation of derivatives and short positions. Refer below for the quarter end leverage value.

Re-hypothecation of assets:

Re-hypothecation refers to the practice whereby the prime broker uses the securities of the fund as collateral for the prime broker's own purposes. The prime broker mandate in place with Peresec does not permit the rehypothecation of assets. The mandate in place with Morgan Stanley & Co. International plc allows for rehypothecation in accordance with the agreed terms. On a daily basis the maximum limit of re-hypothecation allowed is calculated, referred to as the adjusted value, and is reported with the details of any re-hypothecated assets. At quarter end there were no re-hypothecated assets.

Methodology of stress testing:

The methodology for stress testing is based on a regulatory requirement to test the impact on the performance of the fund under outlier events based on historical correlations. H4 uses an external risk data service provider, RisCura Analytics (Pty) Ltd, who has the capabilities to stress test portfolio information through a global risk factor model, MSCI BarraOne. Various stressed environments have been created and their impact assessed on the fund.

H4 are comfortable with the results of the stress testing performed on the fund for the quarter.

Changes to the liquidity profile of the fund:

There were no significant changes to the liquidity profile of the fund.

Investment strategy and mandate

The fund invests across asset classes, both locally and offshore. Significant exposures may be taken in individual positions from time to time. Peregrine Capital employs a bottom up stock selection process based on rigorous and disciplined fundamental research, drawing on experience of covering the sectors and companies over many years. Peregrine Capital focuses its time on building up a detailed understanding of specific companies, rather than predicting the economic trends or taking a view on overall markets.

Risk warning

Calculation of the NAV and price

The value of participatory interests (also referred to as units) is calculated on a net asset value ("NAV") basis. The price of participatory interests is calculated by dividing the NAV by the number of participatory interests in issue for that class. Investment performance

The performance calculated and shown is that of the fund. Performance has been calculated using net NAV to NAV numbers with income reinvested. The investment performance for each period shown reflects the net return for investors who have been fully invested for that period. Individual investor investment performance may differ as a result of initial fees (if applicable), the actual investment date, the date of reinvestment of distributions and/or distribution dates, and dividend withholding tax. Where periods of longer than 1 year are used in calculating past performance, certain figures may be annualised. Annualised performance is the average return per year over the period. A management and performance fee is charged to the fund. Performance fees are payable on positive performance using a participation rate of 20% above the hurdle (STEFOCAD index).
