

INVESTMENT OBJECTIVE

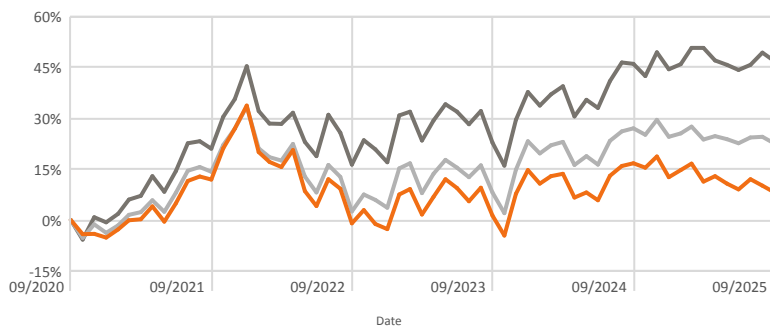
The Reitway BCI Global Property Feeder Fund is a specialist global property portfolio with an objective to provide the investor with income as well as capital growth.

INVESTMENT POLICY

The portfolio will, apart from assets in liquid form, invest solely in the participatory interests of the Reitway Global Property Portfolio, a sub-fund of Reitway Global Property Fund (MLT) Sicav plc, domiciled in Malta. The underlying portfolio invests primarily in a global range of transferable securities of real estate companies and real estate related companies, or in companies which own significant real estate assets at the time of investment or in Real Estate Investment Trusts as well as in exchange traded funds, listed property vehicles and participatory interests of underlying portfolios of collective investment schemes or other similar schemes with similar objectives. The portfolio may from time to time invest in listed and unlisted financial instruments. The portfolio's property exposure will always exceed 80% of the portfolio's asset value.

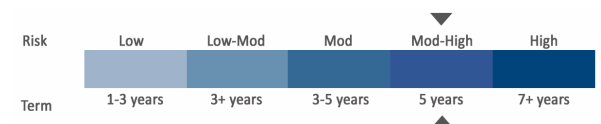
