



The Rexsolom Worldwide Flexible Fund ended the month -1.5 down in ZAR terms but ended up in Dollar terms (0.3%). Over the last 12 months the fund has gained 17.1% in Dollar terms. The month was marked by volatility as markets extended their losses after recording a high on 20 February. The turning point came on the 20th of March as markets found a new level -7.4% lower than the all-time high recorded in February. The pullback in certain stocks allowed for us to include them in the fund. During the month we added Meta to the fund having not owned this before. We also parted ways with Home Depot and Adobe where there are growth concerns. Leonardo, the Italian defence company, saw a 16.3% price gain in the month contributing 1.8% of the portfolio gain. This came off the back of the US pulling away from their NATO commitments and European countries vowing to increase their defence spending. Germany is hoping to spend 5% of GDP in the coming years on defence. The price action in Leonardo pushed the stock to over 10% of the fund as it has gained over 600% in ZAR terms since we have bought. Karoo and LVMH detracted the most from returns during the month.
