What is the fund's objective?

The fund aims to maximise long-term total returns.

What does the fund invest in?

The fund invests in shares of the STANLIB High Alpha Global Equity Fund, which in turn invests in a combination of liquid global stocks across sectors and geographies. The fund will have maximum foreign exposure of 100%.

What possible risks are associated with this fund?

This fund is a feeder fund that invests in an underlying roll-up fund. A roll-up fund does not regularly distribute dividends or interest because income is used to buy additional shares. The possible risks associated with this fund include general market and economic risks such as exchange-rate fluctuations and geographical risk because it includes funds held globally. Where foreign investments are included in the fund, there may be additional risks such as potential constraints on liquidity and the return of funds to South Africa, macroeconomic risks, tax risks, settlement risks, and possible limitations on the availability of market information.

Total Expense (TER): This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. Transaction Costs (TC): This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

Total Investment Charges (TIC): This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.






